## RECYCLING MARKETS REPORT

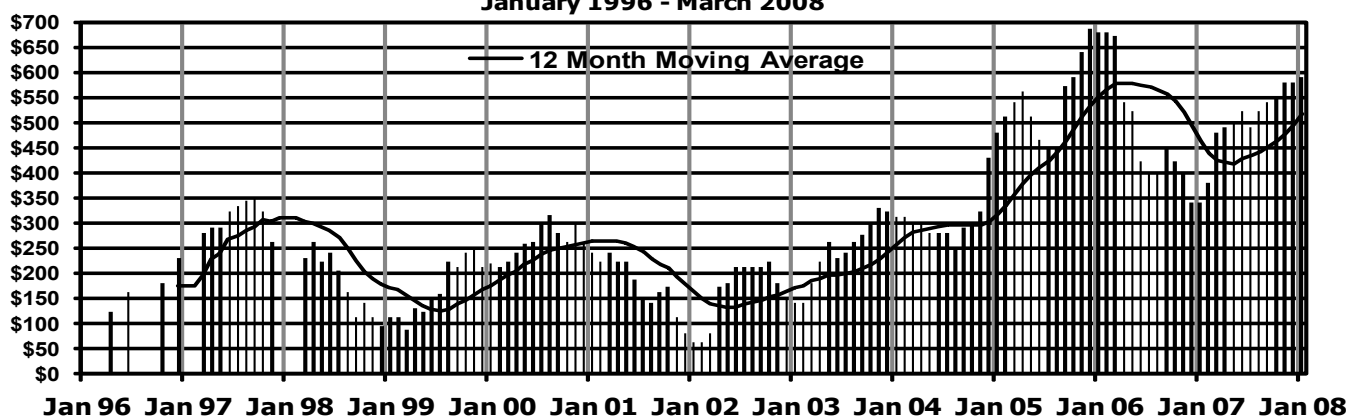
**We leverage our members' tonnage, seeking new markets to get YOU the best prices. How do our prices compare to what you are being offered?**

## **Rebates for Recycling Old Thermostats**

A recent Maine law prohibits the disposal of old mercury-containing thermostats. A program has been set up to allow residents to mail the thermostats to a recycling facility and receive a \$5 rebate. The program was instituted by the DEP in cooperation with the Thermostat Recycling Corporation, a not-for-profit corporation founded and operated by thermostat manufacturing companies. ## **Reduce Junk Mail with 41 Pounds and Congress**

41pounds.org is a nonprofit organization working to eliminate a big personal nuisance and environmental hazard — junk mail. Their name comes from the amount of junk mail the average person receives each year (credit card applications, catalogs, coupon books, etc.) that for the most part goes directly into the trash can or recycling bin. Even with recycling programs all over the country, the majority of household waste is junk mail, and paper takes up about 40% of landfill space! They aim to help you reduce how much you get. Sign up on their web site and they will contact dozens of companies to get you off their mailing lists.

The Center for a New American Dream helps Americans consume responsibly to protect the environment, enhance quality of life, and promote social justice. One of their initiatives is to Tell Congress to Make it Easier for Americans to Opt Out of Junk Mail by creating a Do Not Junk registry similar to the FTC's Do-Not-Call list.
